Annex 1

Pilot Model for Feasibility studies

ID- EPTRI foresees the conduction of some feasibility studies. These studies will be aimed to test the process, the scientific interest, the availability of requested services and facilities that could be needed to conduct paediatric research in the areas of competence of EPTRI. To the aim of conduct feasibility studies, a provisional procedure has been created within WP9. It includes the setting up of an advisory board (AB) to assess these feasibility studies. The provisional procedure includes:

- An official opening of the call for applicants to be sent by the Coordinator.
- Coordinator staff will act as Central Hub managing the contact with the service providers (Platforms, Central Services, Common Services).
- Defined Procedures to apply a proposal send to the users including instruction for the secure use of
 IT tools, for the contents of the proposal and the timing for issuing the AB opinion.
- Defined Format of the application. It should comprise a structured abstract, specific questions regarding the ability of EPTRI to provide a specific service (either technical or expertise based).
- Defined format for the AB consultation process and the points on which the opinion should be articulated including:
 - the proposal meets EPTRI mission and abilities;
 - the proposal is likely to be completed by the end of ID-EPTRI project;
 - the scientific contents are valuable;
 - \circ services and facilities within EPTRI are available to perform the work; etc.

After receiving the opinion on the feasibility of the proposed studies, the Coordinator, (acting as Central Hub) in collaboration with WP9-Other RIs, will contact the concerned thematic Platform that will be in charge to identify the research units and the services needed to conduct the study, to coordinate it and to prepare a study report. After AB will provide its opinion, the Coordinator will disseminate the results to the applicants. Next figure summarises the flow and timing of the feasibility studies procedure :
